## Terms and Conditions governing membership of Iscon Hotels Private Limited

1. Members have to pay a non interest bearing refundable deposit with the club for obtaining membership. The membership tenure is for 25 years from the date of inception. Transfer of membership will be permitted as per the terms and conditions of the club. In case of transfer of membership, the last member holding the membership will get the refund.
2. Membership of the club entitles a member to enter and utilize the club facilities as per Memorandum of Articles, by-laws and the rules and regulations issued from time to time by the Club management, during the tenure of their membership. Members shall have no rights what so ever on the club premises, property or facilities.
3. Each member will be required to pay an annual maintenance fee as per the fee structure announced by the club management from time to time. Maintenance fee has to be paid by all the members who are on the membership list, irrespective of utilizing the club facilities or not.
4. Members have to strictly present the smart card issued to them for entering the club and utilizing the facilities. Guests of members will be allowed, only if they are accompanied by the member and on payment of requisite fees. Members will be fully responsible for the conduct of their guests.
5. In the interest of the security, member's vehicle will be checked and they will be frisked, for which they have to cooperate with the security team. Entry to club can be denied by the management if the member refuses to cooperate in security matters or fails to produce the smart card.
6. The Club Management & various governing/advisory councils will be nominated by the promoters of The IHPL at their sole discretion.
7. The Banquet facilities, Restaurants, Food Court etc shall be operated through reputed parties selected by the club management. The rates, rules and regulations etc shall be finalized by the club management as deemed fit.
8. If any member abuses or misuses any equipment or facility and/or causes damage to the same, the repair/replacement charges will be collected from them.
9. If any member breaks the Club code of conduct, suitable penalty will be inflicted by the club management depending upon the gravity of such act, as per the Club's code of conduct rules.

Detailed Code of conduct, rate lists, statement of terms and conditions are kept at the club office for perusal of members. The club management reserves its rights to amend/delete/add rules and regulations from time to time as deemed fit. The management decision shall be final and binding on all members for all matters.
